63/P Minutes of Previous Meeting

The minutes of the meeting held on 2 March 2023 were confirmed and signed by the Chairman.

64/P Application Number 22/0828/FFU: Land to the West of Church Road, Church Road, West End

The application was for the erection of 6 x 1- bedroom affordable Almshouse bungalows and gardens, including a new access from Church Road, parking areas and bin store.

The application would have normally been determined under the Council's Scheme of Delegation. However, it has been called-in by Cllr Tedder if minded to refuse as the proposal was a rare opportunity for social rented homes.

"The applicant details: Chobham Poor Allotment Charity.

For background information and to assist on the matter of the Thames Basin Heath SPA, an appeal decision from elsewhere in the borough is appended."

As the application triggered the Council's Public Speaking scheme, Mr Julian Marczak and Thomas Rumble, the agent, spoke in favour of the application.

Members had differing views on the application. Whilst there was appreciation by members of the merits of the application, there was acknowledgement of a significant objection from Natural England in relation to the Thames Basin Heath Special Protection Area. As a result, Councillor Edward Hawkins proposed a deferral proposal, which was seconded by Councillor Liz Noble, to allow the applicant to reengage with Natural England, through the pre-application process, in order to seek retraction of the body's objection.

The proposal was put to the vote and carried.

RESOLVED that application 22/0828 be deferred in order to allow the applicant the opportunity to reengage with Natural England to seek retraction of their objections.

65/P Tree Preservation Order 11/22: 54 Church Road, Bagshot

The Committee received a report which proposed to protect a Veteran Beech Tree within 54 Church Road, Bagshot.

This report had been presented to Planning Applications Committee due to the Tree Preservation Order which has been served, receiving letters of objection and therefore could not be considered under the Council's Scheme of Delegation.

The officer recommendation to confirm the Tree Preservation Order with no modifications was proposed by Councillor Victoria Wheeler, seconded by Councillor Valerie White, and put to the vote and carried.

RESOLVED that Tree Preservation Order 11/22 be confirmed.

The application was for the demolition of the existing buildings and erection of a new warehouse for flexible use within Classes E(g)(ii), E(g)(iii), B2 and / or B8.

The application was reported to the Planning Applications Committee because the proposal was a major development (floor area exceeds 1,000 sqm).

Members had concerns about the predominance of the industrial building and built form in the greenbelt and in relation to the streetscene from Highams Lane. It was agreed that a condition would be added to the existing proposed condition 4 to request additional landscaping between Highams Lane and the main building and car park.

The officer recommendation to grant the application was proposed by Councillor Robin Perry, seconded by Councillor Edward Hawkins and put to the vote and carried.
