## 1. **Resource Implications**

## 2. Key Issues

- 2.1 There are various statutes all employers need to comply with which are relevant to our Family Friendly Policies e.g. Work and Families Act 2006. The Children and Families Act 2014 sets out new statutory obligations requiring the update of our Family Friendly Policies.
- 2.2 A summary of the changes is as follows:
  - Maternity fathers can now request leave to attend antenatal appointments/classes
  - Paternity expectant fathers now have more options under the Shared Parental Leave Policy to take time off with their new born or adopted child. Additional Paternity Leave will be removed following implementation of Shared Parental Leave
  - Adoption Shared Parental Leave will give adoptive parents more flexibility
  - Shared Parental Leave Will give greater flexibility in the first year of the birth of a child for both parents or first year following adoption. This comes into effect for births due or adoption placement after 4<sup>th</sup> April 2015.
  - Parental Leave changes affect parents of children under the age of 5 or adopted child or disabled child under the age of 18
