### Annex 1 - Mandatory conditions

#### 1. S19

- i) No supply of alcohol may be made under the premises licence -
- (a) at a time when there is no designated premises supervisor in respect of the premises licence, or at
- (b) a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- ii) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

## Annex 2 - Conditions consistent with the operating Schedule

- 1. The licence holder shall co-operate with the police and authorised officers of the Council when necessary to prevent crime and disorder.
- 2. The sale of food shall be conducted in accordance with food and safety guidelines.
- 3. No activities shall be undertaken at the premises which would cause noise disturbance to the public.
- 4. Any person appearing to be under the age of 21 years who wishes to purchase alcohol shall be required to provide appropriate identification to verify their age.
