County Divisional Boundaries – Review of Polling Districts and Polling Places

<u>Purpose</u>

Following a review by the Local Government Boundary Commission for England (LGBCE), the Council is asked to approve the specified changes to polling districts described in this report. These are required in order to set up the modified electoral divisions for the running of the SCC elections on Thursday 2 May 2013.

Background

- 1. The LGBCE, in 2010/11, conducted a review of the electoral arrangements in Surrey which aimed to ensure that the number of voters represented by each councillor was approximately the same. The Surrey (Electoral Changes) Order 2012, to implement recommendations by the Boundary Commission for new county division boundaries in Surrey, was made on 10 July 2012 and come into force at the next elections for Surrey County Council, in May 2013.
- 2. The effects of the Order for the 6 County Divisions in Surrey Heath are as follows:
 - (a) To create the 2 amended County Divisions comprising the following parish wards
 - i. Bagshot, Windlesham and Chobham; and
 - ii. Lightwater, West End and Bisley.
 - (b) To move 642 properties (867 electors) in the Ansells area from Camberley West to Frimley Green and Mytchett.
 - (c) To move 381 properties (819 electors) on Wellington Park from Camberley East to Heatherside and Parkside.
- 3. The changes introduced by the Order do not amend the Borough Ward boundaries. As a result, the County Divisional boundaries and the Borough Ward boundaries will no longer be coterminous in parts of the four divisions of Camberley West, Camberley East, Frimley Green and Mytchett, and Heatherside and Parkside.

Proposal

- 4. The changes to the polling districts specified in this report are necessary to enable the Returning Officer to conduct the County Council elections in accordance with the modified electoral divisions introduced by the Order.
- 5. As the Council has no power to amend ward boundaries, in order to accommodate the changes to the county divisions it will be necessary to create 2 new polling districts comprising the affected properties at 2(b) and (c).
- 6. It will not be necessary to amend any of the polling districts in parished area of the Borough as the polling district, ward and county divisional boundaries remain coterminous.

- 7. However in relation to moving properties from Camberley West to Frimley Green and Mytchett and from Camberley East to Heatherside and Parkside, it is proposed to create new polling districts, as follows:
 - a. FC (Frimley South)
 - b. EB (St Pauls East)
- 8. The affected roads are set out at Annex A and shown on Annex B. In addition it is proposed that the existing polling district E (St Pauls) be renamed EA (St Pauls West).

Options

- 9. Adoption of the changes to the County Divisions is required by law. However approval by the Council is required to amend polling districts and to designate polling places.
- 10. It is necessary to consider the polling arrangements for the electors in new polling districts of FC (Frimley South) and EB (St Pauls East). The options are set out at Annex C.

Resource Implications

- 11. There would be no additional costs arising from Option A.
- 12. Option B will result in additional costs of approximately £350 once every four years for the County Council elections,
- 13. Option C would result in an additional cost approximately £550 for all 5 types of elections, depending on the cost of the hire of a building. As each authority bears the cost of its own election, this Council would have to meet any additional cost every four years.

Proposal

14. The Returning Officer proposes that Option B be implemented for the forthcoming County Council elections. A further review of polling districts and polling places will be conducted following the Borough Council elections in 2015 when these arrangements will be re-examined.

Recommendation

- 15. The Council is advised to RESOLVE that
 - (i) 2 new polling districts be created comprising the roads set out at Annex A and the polling places be designated as follows:
 - a. FC (Frimley South) St Peters Church Hall, Frimley Green Road, Frimley
 - b. EB (St Pauls East) St Pauls Church Hall, Church Hill, Camberley.
