## 047/C Minutes

The Mayor informed the Council that her Community Christmas Party at Pine Ridge Golf Club had raised just over £1,800 for her charity and she thanked Fascia Place Ltd who had added an additional £500 to that total.

## 050/C Leader's Announcements

Cllr Moira Gibson, the Leader of the Council, informed the Council that in November she had attended a meeting of the South East England Councils Executive, where discussions had focussed on the New Homes Bonus, as it was now known that the funding would not be top sliced in order to provide the funds to Local Enterprise Partnerships (LEPs). However, the LEPs would still receive the same amount of money, which would be received from other decentralised sources of funding. There would be a review of the New Homes Bonus in spring 2014.

The Council was informed that the Enterprise M3 LEP was currently working on its Strategic Economic Plan. Members were advised that Camberley was considered to have great potential for growth and would be featured in some of the interventions which would be put forward by the LEP for Government funding.
