Setting of Council Tax 2014/15

Purpose

To set the Council Tax for 2014/15.

1. Having determined its Council Tax Requirement for 2014/15, members are now required to formally approve the Council Tax for the area taking into account precepts received from Surrey County Council, Surrey Police and Crime Commissioner and the Parishes.

- 2. There are two recommendations in this paper to mirror the options included within the budget paper. These are:
 - Option A 0% increase in Council Tax
 - Option B 1.9% increase in Council Tax

The actual recommendation proposed is dependent on the decision taken in the previous item.

- 3. In approving the Council Tax for 2014/15, Council should note the following:
 - i. The Executive, at its meeting on 7th January 2014, approved the draft Council Tax base for 2014/15 but delegated the final setting of the base to the Executive Head of Finance. The tax base has been set at 36,237.02 Band D equivalent properties.
 - ii. Precepts have been received from the Parishes for 2014/15 and these are shown in this report.
 - iii. The Surrey County Council Precept for 2014/15 is £43,333,315.63 (was £42,023,374.75)
 - iv. The Surrey Police and Crime Commissioner Precept for 2014/15 is £7,670,652.39 (was £7,438,637.66).

Proposals

4. There are two recommendations which depend on the decision taken in the previous paper. These are set out in the annexes below as follows:

Annex A £188.97 for a Band D property, reflecting an increase of 0% and an own Council Tax requirement of £6,847,710 or;

Annex B £192.56 for a Band D property, reflecting an increase of 1.9% and a Council Tax requirement of £6,977,778.

3. The Council will note that Surrey Heath's Council Tax is the smallest of the three principal precepting authorities and represents 11.8% of the total Council Tax Bill. In cash terms this represents 51p per day for each Band D property.
