Purpose

To receive presentations from the Surrey Heath Clinical Commissioning Group, Enterprise M3 Local Enterprise Partnership and Collectively Camberley Business Improve

Surrey Heath Clinical Commissioning Group – Item 5

1. On 1 April 2013 Surrey Heath Clinical Commissioning Group (CCG) took over responsibility for Health matters in Surrey Heath from NHS Surrey, the Primary Care Trust.
2. Surrey Heath Clinical Commissioning Group is fairly unique in that it is virtually coterminous with the Borough Boundaries.
3. The Committee received a presentation from the CCG in March 2013 and will receive an update after its first year's operation.

Enterprise M3 Local Enterprise Partnership – Item 6

4. In 2011 the Enterprise M3 Local Enterprise Partnership (LEP) was established. The LEP is a locally owned partnership between the public and private sector and covers large parts of Surrey and North Hampshire.
5. The Leader of the Council is a member of Enterprise M3's Board, which is responsible for the overall strategic direction of the Partnership. The Implementation Group, which sits under the Board, is comprised of key delivery partners and the chairs of the LEP's Action Groups; the Council's Chief Executive is a member of the Implementation Group.
6. Geoff French, Chairman of Enterprise M3 LEP, will deliver a presentation to the Committee about the LEP.

Collectively Camberley Business Improvement District – Item 7

7. Collectively Camberley Business Improvement District was established in October 2011 for a 5 year period. The Business Improvement District (BID) is funded by the 382 businesses within Camberley Town Centre, which pay a levy based upon their rateable value.
8. Collectively Camberley is a not-for-profit organisation which is steered by a Board comprising members who represent all sectors covered by the BID. The Executive Head of Finance is a member of the Board.
9. The aim of the BID is to work closely with local businesses, as well as to work with partner organisations and other public agencies, to deliver key improvements for businesses within the BID area.
10. Collectively Camberley aims to deliver initiatives in four key areas:-
 - Marketing & Promotion of the Town Centre

- Improving the attractiveness of the Town Centre
- Improved Town Centre access
- Business Support

11. The Committee will receive a presentation from Zoe Griffiths, Managing Director of Collectively Camberley.
