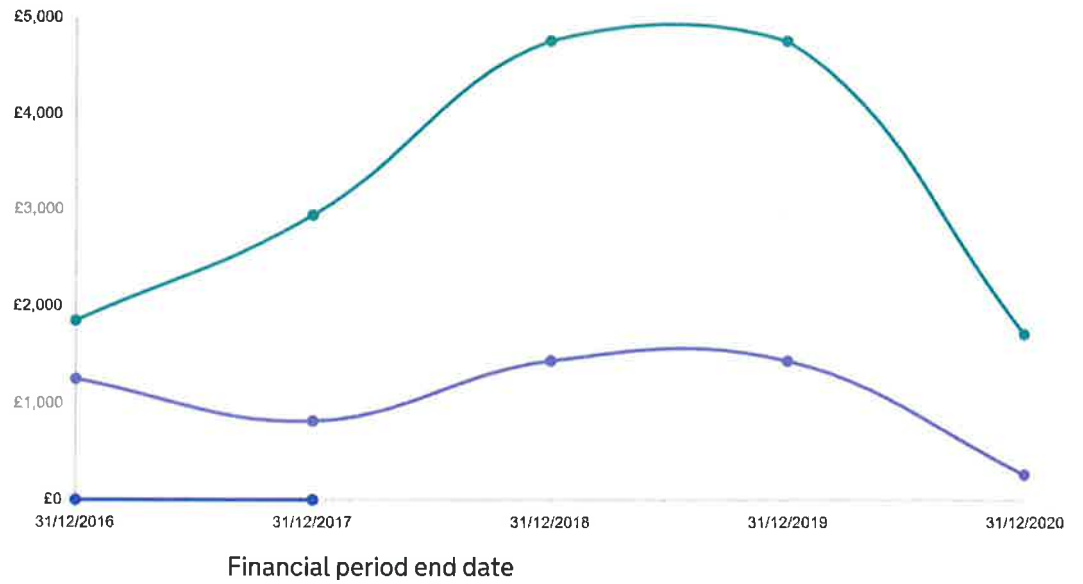

Charitable objects

(1) TO ADVANCE THE CHRISTIAN RELIGION IN CAMBERLEY AND ITS IMMEDIATE SURROUNDINGS FOR THE BENEFIT OF THE PUBLIC INCLUDING, BUT NOT EXCLUSIVELY, THROUGH PRAYER EVENTS, PUBLIC CELEBRATION OF RELIGIOUS FESTIVALS, PRODUCING AND/OR DISTRIBUTING MESSAGES OR LITERATURE ON CHRISTIANITY TO ENLIGHTEN OTHERS ABOUT THE CHRISTIAN FAITH. (2) TO PROMOTE THE PHYSICAL, MENTAL AND SPIRITUAL WELLBEING OF THE PEOPLE WHO LIVE IN, WORK IN OR VISIT CAMBERLEY AND ITS IMMEDIATE SURROUNDINGS, INCLUDING, BUT NOT EXCLUSIVELY, BY BUILDING BETTER RELATIONSHIPS BETWEEN CHURCHES AND OTHER ORGANISATIONS IN CAMBERLEY AND THROUGH THE PROVISION OF PASTORAL CARE AND SUPPORT INCLUDING THE FORMATION OF A STREET ANGELS PROGRAMME, FOR THE BENEFIT OF THE PUBLIC. (3) TO SUPPORT, CARE AND TREAT PERSONS IN NEED WHO ARE HOMELESS OR SUFFERING FROM THE EFFECTS OF POVERTY, SICKNESS, DISABILITY, OLD AGE, ALCOHOLISM, DRUG ADDICTION, OFFENDING BEHAVIOUR, OR ANY OTHER MENTAL OR PHYSICAL INFIRMITY, AS AN EXPRESSION OF CHRISTIAN FAITH.
