WARD: Parkside Applicant: Councillor Josephine Hawkins

Project: Installation of an additional lamp and column and replacement of<br/>existing lamp heads (3) to LEDs, at Southcote Park, Camberley.Grant requested: £6,410 (net)Project cost: £6,410 (net)

The bid is for £6,410 (net) for the installation of an additional lamp and column and to replace the 3 lamp heads on the existing columns to LED. The new lamp and column would be located on the pathway leading from Southcote Park Car Park to Camberley Tennis Club, there are currently 3 lighting columns on this pathway.

VAT would be reclaimed. The path is owned by the Borough Council. The Tennis Club has agreed to take on the ongoing running costs of the additional lamp. The replacement of the existing lamps to LED's would be more energy efficient.

A new lamp column would require planning permission and a planning application has been submitted.

The Lawn Tennis Club has raised concern at the lack of lighting at Southcote Park car park and along the pathway. Members of the club have said that they did not feel safe walking to their cars alone in the dark and similar comments have been made by local residents and other players at the club, suggesting a safeguarding issue in this area.

The installation of an additional light would allow for extra illumination of a corner of the car park and pathway. This could help to reduce anti-social behaviour and is supported by the local Police team. It would also provide reassurance to users of the park and Tennis Club.

These works to improve the play area would support the Council's corporate objectives and priorities;

<u>Environment</u> - To enhance and improve access to the borough's cherished green spaces and natural environments for the enjoyment of generations to come.

## **Bid Summary Application 2**

WARD: St Michaels Applicant: Mr S.Harris, Greenspaces Team, Surrey Heath Borough Council

Project: Resurfacing damaged tarmac pathways at London Road Recreation Ground

Grant requested: £55,000 (net) Project cost: £150,000 (net)

The bid is for £55,000 (net) for the resurfacing of damaged pathways at London Road Recreation Ground. VAT would be reclaimed.

The current pathways are damaged due to weather and tree root egress and are at end of life. Elements of the path pose a health and safety risk as they present trip hazards. The pathways are beyond repair and are in urgent need of resurfacing.

A quotation for the works has been received for a total cost of  $\pounds150,000$ .  $\pounds95,000$  has been agreed through Surrey Heath Borough Council capital funding as Health and Safety works. The remaining  $\pounds55,000$  is sought from CIL. This would ensure all the project works are completed and the paths in the park renewed.

Inspection and maintenance of the pathways would be carried out by the Greenspaces Team.

London Road Recreation Ground is a very popular park and is the main greenspace in the town centre. It accommodates Camberley Bowls Club and tennis courts, a cricket square, a play area and is a popular cut through for people walking into the town centre. Lyndhurst School also has a licence to use the park for their school playing field.

Parks provide quality outdoor provision for health, wellbeing and community cohesion. This park serves as an essential space for the local residents.

The works to improve the footpath would support the Council's corporate objectives and priorities;
